

## Trade Knowledge - Letter of Credit

In an import-export business, Letter of Credit (LC), also known as Documentary Credit, is a major instrument for settling trade payments. It is actually a written commitment from a bank on behalf of a buyer (importer) that payment has been made to a seller (exporter) under agreed terms & conditions. A key principle of LC is that banks have to deal only in documents and not in goods. It is prohibitive for banks to physically examine whether all products have been shipped exactly as per Letter of Credit. LC is defined by the International Chamber of Commerce (ICC) in Article 2 of the Uniform Custom and Practice for Documentary Credit (UCPDC), ICC Brochure 600 as –

"Any arrangement, however named or described, that is irrevocable and thereby constitutes a definite undertaking of the issuing bank to honour a complying presentation."


## **How Letter of Credit (LC) Works?**

The existing advantages of LC based transactions have contributed to a large extent to the growth of international trade in modern times. The working of LC involves parties to commercial Letter of Credit and steps in the process of LC that is discussed below.

#### Parties to Letter of Credit:

- **1. Applicant (Importer or Buyer):** An Applicant is a buyer (importer) of the goods, who has to make payments to the beneficiary.
- **2.** Issuing Bank (Buyer's Bank): Issuing Bank creates a letter of credit and undertakes to make payments.
- **3. Beneficiary : (Exporter or Seller)** Beneficiary is normally a seller (supplier, exporter) of merchandise who has to receive payment from the Applicant (importer).
- **4. Advising Bank:** The role of Advising Bank is to give credit advice to the Beneficiary, thereby assuring the genuineness of the credit. The bank is normally situated in the country of Beneficiary (in India, in our case). Main function of Advising Bank is to inform and communicate to the beneficiary that a LC has been issued in his favor.

## Letter of Credit (LC) - Process Flow



## Most common Types of Letter of Credit:

**Irrevocable Letter of Credit:** This type of LC can't be amended or cancelled by the Issuing Bank without the consent of parties to LC, particularly the Beneficiary. It is more favorable as per exporter's point of view.

**Confirmed Letter of Credit:** This LC is issued after guarantee or confirmation by another bank other than Issuing Bank. Thus, there is a double guarantee to this credit and it is more favorable to the Beneficiary. This type of LC is costlier as there are charges to be paid to the Confirming Bank.

**At Sight Letter of Credit** in the Sight Letter of Credit, Issuing Bank has to made payment at the sight, on demand or on presentation.

**Usance Letter of Credit:** in Usance Credit, drafts are drawn on the issuing bank or the correspondent bank at specified Usance period.

## Advantages & Disadvantages of LC to Importer & Exporter



## **Advantages**

- ➤ An Importer is assured that payment has been made to an Exporter under terms & conditions mentioned in LC.
- ➤ Ability to negotiate more favourable trade terms with the Supplier when payment by LC is offered.

## **Advantages**

- ➤ Exporter receives the payment under all terms & conditions mentioned in LC.
- Shifts credit risk from the Importer to Issuing Bank.

## **Disadvantage**

 LC assures right documents but not necessarily right merchandise.

## **Disadvantage**

➤ Documents get prepared in strict compliance with all requirements specified in LC. Non-compliance leaves Exporter exposed to risk of non-payment.




Total consumption and market demand in the country is around **1 million tonne per year.** There is a shortage of arecanut," he said. However, import of arecanut has gone up by more than 100%, both in terms of quantity and value, during the first eight months of the current financial year.

## **Areca Nuts Market Analysis:**

The Areca Nuts Market size is estimated at USD 0.92 billion in 2024, and is expected to reach USD 1.16 billion by 2029, growing at a CAGR of 4.73% during the forecast period (2024-2029).





## **Consumption Habits:**

- ➤ India is the largest producer of Areca nuts / Supari / betel nuts
- ➤ India is the largest consumer of Areca nuts.
- > Indians eat Areca nuts and Areca leaves as a mouth freshener.
- > Various regions have their cultural traditions of pan (areca nut + leaf with other condiments like tobacco etc.)
- > The ever-growing demand for areca products, such as pan, scented supari, and pan masala in countries like Sri Lanka, Nepal, the United Arab Emirates, Mexico, Thailand, and Singapore drives the growth of the areca nut market.
- > Total consumption and market demand of areca nuts in India is around one million ton per year.
- > There is a shortage of areca nut in India against the consumption.
- > Import of arecanut has gone up by more than 100%, both in terms of quantity and value, during the first eight months of the current financial year.

## **Importing Areca Nut:**

Minimum Import Price (MIP) has been fixed at Rs. 251/kg on areca nut and import of areca nut is prohibited, if the CIF (Cost, Insurance and Freight) value is below Rs. 251/kg. Thus, adequate measures have been placed so as to prevent import of cheap areca nut into the country.



## **Varieties of Areca Nuts:**

Mangala, Sumangala, Subamangala, Mohitnagar, Srimangala, Samruthi (Andaman), Hirehalli dwarf, VTLAH 1, 2 and Thirthahalli dwarf. Arecanut is capable of growing in a variety of soils. It thrives best in well drained soils.





In India there are **two varieties** of areca nut, also called supari in Hindi language.





## **Quality Parameters:**

In arecanut, plant height, husk thickness, kernel breadth and dry weight of kernel are important characters to be accounted for gaining improvement in yield per palm.

Fully ripened nuts having weight of above 35 g should be selected. The nuts selected should float vertically with calyx-end pointing upwards when allowed to float on water.

Sevardhan Betel Nuts (Diameter Around 24mm to 26mm) Betal Nut is an important crop in India and finds a place in all religious, social and cultural functions and events in India.



### **Uses of Areca Nuts:**

Areca nut and the plant as a whole is used widely in India and South Asia as: a masticator for chewing purposes, vegetable, medicine, stimulant, timber, fuel wood, clothing, wrapping, lubricant, tannin and so forth. The nut is chewed with the betel leaf as it has a stimulating effect.

Areca nut husk is used to make many industrial products such as hardboard, insulation wool, cushions, paper, paper board and activated carbon.

  - Small quantities can be packaged in stand-up pouches

## **Pricing and Margin:**

- ➤ The right quality of areca nuts is priced in India at Rs. 2500 to 5000 per 100 kilogram (or one quintal).
- ➤ In the domestic market and also abroad, areca nuts fetch a high margin.

- ➤ Areca Nuts (whole) can fetch an FOB price of USD 5.50 to 7.00 per Kg. This is an indicative price.
- > Areca Nuts is a commodity, hence regular price index must be checked before exporting or importing.
- > The price of arecanut in the major markets of Karnataka is on the rise due to both a supply shortfall and rising demand.

- > Swiss, officially the Swiss Confederation is a country located primarily in Western Europe.
- > Swiss shares borders with France, Germany, Austria and Italy. It is a landlocked country.
- > Switzerland is the birthplace of the Red Cross and hosts the headquarters or offices of most major international institutions, including the WTO, the WHO, the ILO, FIFA, and the United Nations.
- ➤ It is a founding member of the European Free Trade Association (EFTA), but not part of the European Union (EU), the European Economic Area, or the eurozone.
- > Switzerland is a neutral European country, which is not a member of the North Atlantic Treaty Organization (NATO).
- ➤ The European Free Trade Association (EFTA) is the intergovernmental organization of Iceland, Liechtenstein, Norway and Switzerland. It was set up in 1960 by its then seven Member States for the promotion of free trade and economic integration between its members.

- > Switzerland is known by multiple native names: depending up on the predominant languages. On coins and stamps, the Latin name, Confoederatio Helvetica—frequently shortened to "Helvetia"—is used instead of the spoken languages.
- Switzerland is a founding member of the EFTA. European Free Trade Association EFTA – includes Iceland, Liechtenstein, Norway and Switzerland.
- > Switzerland is geographically divided among the Swiss Plateau, the Alps and the Jura; the Alps occupy the greater part of the territory, whereas most of the country's population of 9 million are concentrated on the plateau, which hosts the largest cities and economic centres, including Zürich, Geneva and Basel.
- Switzerland is one of the world's most developed countries, with the highest nominal wealth per adult and the eighth-highest gross domestic product (GDP) per capita.



Since the Swiss Customs Act 2005 came into force in 2009, free ports are within the Swiss customs territory, albeit subject to a specific customs regime. Goods stored in a free port do not go through Swiss Customs.

Their duty-free status is unaffected.
