
It's a double whammy!



We have received queries on if International Trade can be invoiced in Indian Rupees (INR) while exporting.

In July 2022, the RBI made a big announcement of settling international trade in INR. This was not just a stir in a teacup. In just 5 months after this announcement, trading with countries happened in INR transactions.

International trade settlement in INR takes much more than the export business. It requires trust, especially when the world is facing inflation, growth rates have slowed or paused, Indian Rupee is sliding down, countries are being sanctioned, and more. But of course, the RBI made a thoughtful more. Yes, we can use INR in International Trade. Prarambh notes here the benefits of using INR:

- Indian Currency can be in demand. More demand, the higher the Value.
- India can keepits Foreign Currency Reserve intact.
- Indian can trade with "Sanctioned Countries" Countries that are under Sanctions from the West, like Russia, Iran, Venezuela, etc.
- India can control Inflation.





# From the Editor's Desk Trupti Shah, VP Support, iiiEM

This initiative will change the age-old dependency on the dollar. About 60% of India's international trade is done using USD. About 86% of Imports in India are made using USD. This way India will save its foreign currency reserves. In the best-case scenario, if India pays for all of its Russian imports in rupees, it would end up saving \$30-36 billion in dollar outflows.

The RBI has allowed the following countries to open Vostro accounts for international trade in INR.

There are special agreements for Bhutan and Nepal for trade settlement & invoicing in INR.

There is also a different agreement with Iran using INR for cross-border trade.





## **Country Profile - Singapore**

- The Republic of Singapore is an island country and city-state in maritime Southeast Asia.
- ▶ It lies north of the equator, off the southern tip of the Malay Peninsula, bordering the Strait of Malacca to the west, the Singapore Strait to the south, the South China Sea to the east, and the Straits of Johor to the north.
- Singapore has the world's highest percentage of millionaires, with one out of every six households having at least one million US dollars in disposable wealth.
- Singapore has a highly developed market economy, based historically on extended entrepôt trade. Along with Hong Kong, South Korea, and Taiwan, Singapore is one of the Four Asian Tigers.

- Singapore's agriculture is urban agriculture and aquaculture, and the licensed farms in Singapore mainly focus on three main types of produce: Like, fish and seafood, vegetables, and hen eggs.
- Major Industries: Electronics, Chemicals, Biomedical sciences, Logistics and transport engineering, Precision engineering, medical technology, aerospace engineering, clean energy, healthcare, etc.
